**INSTRUCTIONS**

1. Write your name, address and signature on the back of the ticket. Complete the claim form as per the instructions provided. **Indicate the prize amount legibly.**
2. The winning ticket and claim form must be completed in the name of one individual or legal entity.
3. You are required to approach any retailer selling Online Lottery of the Government of Arunachal Pradesh and get your ticket validated.
4. Prize amount not exceeding Rupees Five Thousand (Rs. 5000/-) shall be paid by the Retailer. Prize amount above Rupees Five Thousand (Rs 5000/-) shall be paid directly by the Director State Lotteries, Government of Arunachal Pradesh. The prize amount shall be claimed by submitting a claim form along with 2 passport size photographs duly attested by a first class magistrate/notary. The claim may be sent to the nearest office of Kenlott Gaming Solutions Pvt. Ltd.(Kenlott), the addresses for which are given below, **in person or by registered post** at claimant's own risk. Payment will be made after deducting the tax as applicable on the date.
5. Prizes will be given only on complete physical verification of the documents, ticket and proof of identity to the absolute discretion of Government of Arunachal Pradesh. Decision of Government of Arunachal Pradesh shall be final and binding on the Claimant.
